Programme Overview:

The Certificate in Occupational Health and Safety aims to provide participants with the core skills to advise their employers on a range of occupational health and safety issues. The programme will give participants an in-depth understanding of the key areas of occupational health and safety (OHS) legislation and guidance.

Programme Outcomes:

On successful completion of this course, delegates will be able to:

- Identify common hazards and risks in the workplace and advise on suitable corrective actions
- Identify sources of guidance and advice on health and safety
- Assist in the preparation and regular review of an organisation's OHS management system
- Recommend suitable action to minimise risks
- Investigate accidents, prepare reports
- Make cost effective proposals to prevent recurrence
- Identify the main requirements of legislation and codes of practice and maintain records and information to advise management

Approach:

There are a number of activities and case studies as part of the course to ensure that the key knowledge and skills are practiced. Programme participants are encouraged to express their views and experiences. The programme facilitates participant discussion to ensure a thorough understanding of the key points and their application. Real life case studies and exercises will be used to ensure a real practical understanding of each topic.

Assessment Strategy

Participants will be assessed according to the following criteria:

- 1. Participants are required to complete a 2,500-3,000 word project on one of the subject areas covered. Participants will be given a project title on one of the subjects. The essay will constitute 30% of the end of year marks and will include a risk assessment within their own organisation.
- 2. Participants will be required to sit an end of year exam on the areas covered during the CPD Certificate. The exam constitutes the remaining 70% of end of year results.

Who Should Attend?

The programme is designed to provide a recognised qualification for those with a professional interest in or involved in the application of occupational health and safety at work. Therefore, participants are required to be working in the area of Occupational Health and Safety (OHS) or Management or intending to move into this field. Candidates should have completed as a minimum a Level 6 on the National Qualifications Authority of Ireland (NQAI) Framework.
